<a href="#"><u>SHARED CARE SCOTLAND - SHORT BREAKS FUND</u></a> <b>CREATIVE BREAKS</b>	5pm 22nd May 2025	<p>£1.5 M funding for short breaks projects for carers and the people they care for: APPLY NOW!</p> <p>The <a href="#">Creative Breaks</a> programme provides 12 month grants to third sector organisations to develop and deliver short breaks projects and services for carers of adults (aged 21 years and over), and young carers (caring for children or adults), and the people that they care for.</p> <p>Short breaks activities can take many different forms – including breaks away (i.e., overnight stays, residential breaks), days out, and/or shorter sessions (i.e., regular activities). Activities must be designed to</p>

enable carers to have a life outside or alongside their caring role, and to support their health and wellbeing. Short breaks should also benefit the cared-for person and others (e.g., family members) and help sustain the caring relationship.

Short break activities can be for the carers, for the people they care for, or for both the carers and the cared-for people to enjoy together. To be eligible for Creative Breaks funding, projects must be able to evidence how their activities will benefit both the carers and the people they care for, by providing a break from their normal routine.

A total of around £1.5 Million is available. Grants are for one year (October 2025 – September 2026).

Equal priority will be given to the cultural and social ambitions of projects, and they expect these two ambitions to work together to realise the fund's aims. The fund will support film exhibitors, film distributors, and other organisations delivering audience development activity with multi-year and short-term projects as well as research and development.</p> <p>Applications are accepted all year round but must be submitted 16 weeks before the start of any funded activity. They can support projects of any duration but all activity must be completed by 31 March 2026 unless you have approval from the Audiences team prior to making an application.</p>

<a href="#"><u>BUTTLE UK</u></a>	<b>Ongoing</b>	<p>Grants up to £2,400 for children and young people who have recently come through a crisis.</p> <p>Award grants that support children and young people's education and wellbeing. While our grants can contain funding for household items, it isn't the main purpose of the grant. Applications must be made by a support worker who is working closely with the family or young person. Support workers are also responsible for spending the grant and providing receipts.</p>

<p><a href="#"><u>CASH FOR KIDS - COST OF LIVING GRANTS</u></a></p>		<p>Cash for Kids is supporting children and young people through the cost-of-living crisis, with £1.6 million available to support 32,200 children across the UK.</p> <p>In response to the crisis hitting so many families right now we've launched this new fund, to provide emergency essentials that support the physical and mental well-being of children who are struggling. These could include food, clothing and household energy costs, but we'll also consider anything that helps meet children's most basic needs.</p> <p>Grants are £50 per child per household, and we aim to get the funds to families as soon as possible.</p>
