IMPORTANT CHANGES TO DISCLOSURE SERVICES/ CHANGES TO THE PROTECTING VULNERABLE GROUPS (PVG) SCHEME

From 1st April 2025 the Protecting Vulnerable Groups (PVG) scheme becomes a legal requirement in Scotland.

It will be a legal requirement for individuals to be a member of the PVG Scheme when carrying out a regulated role with children, protected adults, or both. Organisations must ensure that individuals who are to carry out a regulated role (paid or voluntary) have PVG scheme membership from 1st April 2025 onwards.

From this date, 'regulated work' will be replaced by 'regulated roles'. Disclosure Scotland expect that roles which are currently included under regulated work, will also be regulated roles. However, the introduction of 'regulated roles' will bring new roles into the PVG scheme that are currently not regulated work. Examples include, football agents, talent scouts, hypnotherapists and certain hospital or hospice-based roles that do not currently qualify for the PVG scheme.

Make Sure You're Ready!

The Disclosure Act will improve the disclosure system in Scotland by removing unnecessary barriers for people with convictions as they seek employment or other opportunities and enhance the Protecting Vulnerable Groups (PVG) scheme. Upcoming changes will be introduced in 1 April 2025 and charities, particularly those who work with vulnerable adults or children, should be aware of what's changing.

Key Changes from 1 April 2025:

- Reduction in Disclosure Products
- Applicants control their information, sharing disclosures or seeking reviews.
- Tailored approach to childhood offences and conviction reviews.
- Mandatory PVG Scheme: Required for regulated roles with children and protected adults.

THE HEAT NETWORKS REGULATION: IMPLEMENTING CONSUMER PROTECTIONS CONSULTATION IS OPEN

The Department for Energy Security and Net Zero and Ofgem have launched the heat networks regulation: implementing consumer protections consultation. They are seeking your views on consumer protection requirements such as standards of conduct, protections for vulnerable consumers and more. This consultation will be of particular interest to consumer groups, those in the heat network industry (such as developers) and local government. Ofgem are hosting a series of webinars to explain the key proposals in the consultation and you will have the opportunity to ask questions.

The consultation will close at 11:59pm on Friday 31 January 2025.

SCVO: GOOD GOVERNANCE: FUTURE PROOFING FOR TRUSTEES CONFERENCE - RESOURCES

SCVO brought together 100 trustees and charity and governance experts to celebrate Trustees' Week 2024 at our 'Good Governance: Future proofing for trustees' conference in Edinburgh. They celebrated the work trustees do and shared inspiration, experience and knowledge. It was an opportunity to reflect, and develop knowledge and understanding of good governance.

ALCOHOL-FREE CHILDHOOD CAMPAIGN

The Alcohol-Free Childhood campaign from Alcohol Focus Scotland, BMA Scotland, Children in Scotland, Scottish Families Affected by Alcohol and Drugs, and Scottish Health Action on Alcohol Problems is backed by around 50 organisations and 80 MSPs across all parties. HUMAN RIGHTS IN THE HIGHLANDS AND ISLANDS

The <u>Scottish Human Rights Commission</u> has <u>published a new report</u> exploring its concern about the economic, social and cultural rights in the Highlands and Islands. Through listening to the lived experiences of residents and organisations in the area, they've identified a range of issues affecting communities, and a lack of available data for monitoring compared to the rest of Scotland.

THE COMMUNITY LEARNING EXCHANGE FUND

Access to youth work for young people across Scotland could soon be enshrined in law, after Scottish Labour MSP Martin Whitfield launched a public consultation on a proposed Youth Work (Scotland) Bill.

This legislation aims to embed youth work as a statutory service, ensuring equitable provision for all young people and addressing longstanding disparities in access and support. If enacted, the legislation would establish a legal right for all young people aged 11 to 25 to access high-quality youth work services, setting a new standard for equitable provision across Scotland.



DISABILITY COMMISSIONER (SCOTLAND) BILL REPORT
